CULTURAL INSTITUTIONS, REGIONAL ACTIVITIES

In reply to Mrs REDMOND (Heysen-Leader of the Opposition) (7 October 2010).

The Hon. M.D. RANN (Ramsay—Premier, Minister for Economic Development, Minister for Social Inclusion, Minister for the Arts, Minister for Sustainability and Climate Change): I have been advised the following:

Each of the institutions you mentioned, the Art Gallery of South Australia, Carrick Hill, South Australian Museum, History SA and the State Library of South Australia undertake activities for the benefit of South Australians outside of the metropolitan area.

You would be aware that the State's second Regional Centre of Culture (following on from Port Augusta, which has the honour of being our first, in 2008) was held in Murray Bridge in 2010.

The State Library of SA, SA Museum, Artlab, Carrick Hill and History SA have each contributed to the 2010 SA Regional Centre of Culture program in Murray Bridge.

History SA ensured that Murray Bridge was a focus during SA History Week in late May 2010, organising activities highlighting the history of the town. In addition, the 19th State History Conference Cross-Currents: History, People and the Environment was hosted by History SA in Murray Bridge, with a program rich in histories of the River Murray and Lakes, and of the region's people, places and communities.

Specialist conservators from Artlab organised a three-day workshop Caring for Collections, in collaboration with History SA, at Murray Bridge's Pomberuk Cultural Centre in March 2010, for community museums, archives, galleries and libraries. Interactive sessions covered identifying risks to collections, managing the collection environment (including pest management), cleaning collection items and display storage areas and storing and displaying collection items (including textiles and paper).

The SA Museum took its *Out of the Glass Case Roadshow*, showcasing scientific and cultural collections and stories from the Murraylands, to the Murray Bridge Town Hall in July 2010, offering school workshops and a community day.

Carrick Hill's exhibition *A passion for flowers* has been on display in the Murray Bridge Regional Gallery and, to coincide with the exhibition, Carrick Hill's head gardener held an information session on dry climate gardening for the Murray Bridge community.

To support the celebrations for Murray Bridge as the 2010 Regional Centre of Culture, the State Library of SA (SLSA) published a new guide featuring a blend of SLSA content from *Flickr* populated on a Google Map, to provide the user with a Then and Now view of Murray Bridge. The guide is available at: http://guides.slsa.sa.gov.au/murraybridge. This application allows for SLSA content to be populated and discovered in established social networking spaces and provides for new opportunities to create more SA Memory content.

In addition to the cultural institutions' contribution through the Regional Centre of Culture program, a number of other regional programs are regularly undertaken. Some examples include:

- bringing the SA Museum's Out of the Glass Case Roadshow to the APY lands: This Roadshow was many years in the making and was the largest and most complex road show to date. This project won the Ruby Award for Community Impact under \$100,000 award and reached approximately 640 students from nine school communities.
- improving online access to collections: As a number of the State's collections cannot tour due to requirements for environmental controls, the cultural heritage institutions continually work to make more of the State's collections acc3essible online. In 2009-10, the Art Gallery of South Australia added over 3,000 images of the State's impressive art collections online. This allows the public to have 24 hour access to heritage materials across the State, and indeed the world.

- holding satellite events: The SA Museum Palaeontology Week also undertook a Roadshow, holding satellite events in Burra, Naracoorte, Kangaroo Island and Coober Pedy.
- running grant programs to support regional South Australia: History SA runs two grant programs that support communities within and outside of the metropolitan area. The Community Museums Program provides advice, training and support to museums throughout South Australia. In 2009-10, \$146,000 was provided for 29 projects around the state. The South Australian History Fund provides funding for individuals and community groups to undertake projects, publications and research relating to South Australia's history. This program provided \$45,000 to 16 projects, seven publications and a research project.

As I've demonstrated, our cultural institutions regularly participate in a range of activities around South Australia. In addition, they are increasingly providing services and collections online, creating a pathway to these iconic institutions throughout South Australia and around the world.

ARTS SA, GREENHOUSE GAS EMISSIONS AND ENERGY USE

In reply to Mrs REDMOND (Heysen—Leader of the Opposition) (7 October 2010).

The Hon. M.D. RANN (Ramsay—Premier, Minister for Economic Development, Minister for Social Inclusion, Minister for the Arts, Minister for Sustainability and Climate Change): I have been advised the following:

Yes, energy savings and greenhouse gas emissions are measured separately. The baseline figure is the 2007-08 energy consumption of 13,642 GJ, with the Greening of the Gallery project forecast to achieve a 20 per cent reduction in energy consumption at the Art Gallery of South Australia.

AUDITOR-GENERAL'S DEPARTMENT

In reply to Mrs REDMOND (Heysen—Leader of the Opposition) (7 October 2010).

The Hon. M.D. RANN (Ramsay—Premier, Minister for Economic Development, Minister for Social Inclusion, Minister for the Arts, Minister for Sustainability and Climate Change): I have been advised the following:

During 2009-10 the Department of Treasury and Finance provided agencies with additional appropriation to adjust an agency's funding for the outcome of enterprise bargaining and executive salary increases.

The Department of Treasury and Finance provided the Auditor-General's Department with \$112,000 of additional funding in 2009-10 to meet the additional costs arising from the government wide outcomes of enterprise bargaining and executive salary increases. This is a normal part of the budgetary process and the additional funding is initiated by the Department of Treasury and Finance and was disclosed as a separate item of income from the SA Government in the budget papers.

AUDITOR-GENERAL'S DEPARTMENT

In reply to Mrs REDMOND (Heysen-Leader of the Opposition) (7 October 2010).

The Hon. M.D. RANN (Ramsay—Premier, Minister for Economic Development, Minister for Social Inclusion, Minister for the Arts, Minister for Sustainability and Climate Change): I have been advised the following:

The Auditor-General's Department made a loss on disposal of laptop computers of \$13,000 in 2008-09 compared to the budgeted loss of \$4,000. The actual result varies each year depending on a range of factors including the market for laptop computers and the timing of the upgrade and disposal of laptop computers.

The Auditor-General's Department received \$10,000 in other income in 2008-09 compared to the budget of \$5,000. The department has an annual budget of \$5,000 per year and the actual result varies depending on the nature and size of the miscellaneous forms of other income received in a particular year. In 2008-09, other income comprised:

- commissions levied on certain payroll deductions as required by Treasurer's Instruction 8
- bank interest received

 administrative fees recovered from employees to recover the costs of administering their personal salary sacrifice arrangements.

ART GALLERY UPGRADE

In reply to Mrs REDMOND (Heysen—Leader of the Opposition) (7 October 2010).

The Hon. M.D. RANN (Ramsay—Premier, Minister for Economic Development, Minister for Social Inclusion, Minister for the Arts, Minister for Sustainability and Climate Change): I have been advised the following:

In July 2007, Arts SA commenced the Greening of the Gallery project to upgrade the air conditioning and lighting within the Elder and Melrose Galleries of the Art Gallery of South Australia.

A total project budget of \$2.5m inclusive of all fees was allocated. These funds were allocated for both the air conditioning upgrade and the new lighting system for the Elder and Melrose Galleries.

The first phase of the project, being the upgrade to the air conditioning within the Elder and Melrose Wings, was completed in January 2010 and is achieving the recommended climate conditions for the collections.

On 20 September 2010, the second, and final, phase of the project to upgrade the lighting system within Galleries 1, 2, 3 a, b and c commenced construction. This phase of the Greening of the Gallery project is programmed for completion in December 2010.

As the second, and final, phase of the Greening of the Gallery project is not yet completed, full project details are included in the 2010-11 Capital Investment Statement, Budget Paper 5.

TAXATION, GST AND ROYALTY REVENUE

In reply to the Hon. I.F. EVANS (Davenport) (7 October 2010).

The Hon. K.O. FOLEY (Port Adelaide—Deputy Premier, Treasurer, Minister for Federal/State Relations, Minister for Defence Industries): The Honourable Member I. Evans asked for a year by year breakdown of the estimated \$1.4 billion tax, GST and royalty revenue shortfall figure quoted in the 2010 11 Budget papers.

The \$1.4 billion estimate relates to total revisions to revenue from taxation, GST and royalties over the period 2008-09 to 2012-13 between the 2008 09 Budget and 2010-11 Budget, and excludes the impact of taxation and royalty measures introduced in the 2010-11 Budget.

HOUSING SA RENTS

In reply to Ms CHAPMAN (Bragg) (8 October 2010).

The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Housing, Minister for Ageing, Minister for Disability): The inclusion of the one-off increase in rent calculations will only affect people on single rate pensions as the increase for couples is paid in the pension supplement, which is not treated as assessable income for the purposes of calculating social rental housing rents.

Single pensioners also received a small increase of \$2.50 per week, which is paid in the pension supplement. This will not be included in rent calculations.

Modelling undertaken in July 2009, prior to the implementation of the one-off increase, indicated that 22,190 households had an occupant receiving a single rate pension and would therefore be affected by the inclusion of the one-off increase in rent calculations.

HOUSING SA PROPERTY

In reply to Ms CHAPMAN (Bragg) (8 October 2010).

The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Housing, Minister for Ageing, Minister for Disability): The maintenance budget for non-fair wear and tear in 2009-10 was \$4.92 million—an increase of \$840,000—with actual expenditure of \$4.52 million.

This allowed for a one-off increase to repairs identified through the introduction of annual home visits to all public housing properties in March 2009. More than 50,000 visits were conducted from March 2009 to 30 June 2010.

The annual budget for non-fair wear and tear in 2010-11 is \$4.08 million which reflects a return to normal operating conditions.

Housing SA seeks to recover all non-fair wear and tear charges from tenants.

VOLUNTEERS, POLICE CHECKS

In reply to Ms CHAPMAN (Bragg) (8 October 2010).

The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Housing, Minister for Ageing, Minister for Disability): Volunteers play an important role in our community from helping at hospitals and in schools, assisting newly arrived immigrants settle into the community, accompanying young children on family visits or providing social support to isolated people. The State Government appreciates the many people who volunteer their time to help in their community and in particular, the work that is done to support older people in aged care settings and in their own homes.

Many organisations require volunteers to undertake a criminal history check.

The government meets the cost of police checks for volunteers who work with vulnerable groups such as children, the aged and frail, or people with a disability. South Australia is the only State to do this.

To ensure volunteers are eligible for a free check, community organisations need to register for a Volunteer Organisation Authorisation Number (known as a VOAN).

Community organisations are eligible for a VOAN if they meet the following criteria:

- Service delivery involves volunteers having personal contact with vulnerable groups (i.e. children, the elderly, people with a disability)
- Services provide a charity or community service good
- Are incorporated and are non-government
- Are not members, affiliated clubs or an association of a larger organisation

Volunteers within the Department for Families and Communities (DFC) are required to undergo a National Criminal History Record Check prior to commencing their role, with these checks repeated every three years. DFC undertakes these checks at no cost to the volunteer.

There is no plan to change the existing practices.

HOME AND COMMUNITY CARE

In reply to Mr MARSHALL (Norwood) (8 October 2010).

The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Housing, Minister for Ageing, Minister for Disability): A decrease in the reported total hours of Home and Community Care (HACC) services provided by HACC funded agencies from 2008-09 to 2010-11 was observed in the Portfolio Statements. The 2009-10 data which contributed to the 2009-10 estimated figure and the 2010-11 target figure was provisional at the time of publication.

Revised figures based on 2009-10 finalised data reflect an increase in the 2009-10 reported HACC hours from 3,907,900 hours to 3,962,400 hours. It is also anticipated that 4,104,400 hours of HACC service will be provided in 2010-11 and not 3,866,300 hours as reported initially.

SUPPORTED ACCOMMODATION FUNDING

In reply to Ms CHAPMAN (Bragg) (8 October 2010).

The Hon. J.M. RANKINE (Wright—Minister for Families and Communities, Minister for Housing, Minister for Ageing, Minister for Disability): As at 30 June 2010, \$0.393 million had been spent on the following under the Supported Accommodation for People with Disability and Ageing Carers Program:

- land purchases and development within the metropolitan area
- land purchase and development in regional area (Loxton)

All projects under this program are scheduled for completion in 2011.

COMPLIANCE AND ENFORCEMENT

In reply to Ms CHAPMAN (Bragg) (8 October 2010).

The Hon. G.E. GAGO (Minister for State/Local Government Relations, Minister for the Status of Women, Minister for Consumer Affairs, Minister for Government Enterprises, Minister for the City of Adelaide): I am advised that:

The decrease in the net cost of the sub-program from the 2009-10 Budget of \$3.176 million to the 2010-11 Budget of \$2.802 million is mainly due to:

- funding to implement reform under the COAG National Partnership Agreement which is now shown in sub-program 3.5 instead of sub-program 3.3. As this funding related to policy resources, this change has been made to more appropriately recognise this funding against sub-program 3.5 (Communication, Policy and Research), and
- savings allocated to the Office of Consumer and Business Affairs for 2010-11.

PREMIER'S WOMEN'S DIRECTORY

In reply to Ms CHAPMAN (Bragg) (8 October 2010).

The Hon. G.E. GAGO (Minister for State/Local Government Relations, Minister for the Status of Women, Minister for Consumer Affairs, Minister for Government Enterprises, Minister for the City of Adelaide): I am advised that:

1. Access to the Premier's Women's Directory search facility is managed by the Office for Women. Access to the directory has been available to government and not-for-profit agencies since its inception. However, the Office for Women has been proactively targeting access for the private sector since the supplementary target to South Australia's Strategic Plan target 5.1 was set in 2007.

ONLINE TRANSACTIONS

In reply to Mr GRIFFITHS (Goyder) (8 October 2010).

The Hon. G.E. GAGO (Minister for State/Local Government Relations, Minister for the Status of Women, Minister for Consumer Affairs, Minister for Government Enterprises, Minister for the City of Adelaide): I am advised that:

Of the approximately 2.1 million transactions conducted online, around 1.4 million were vehicle registrations, around 18,500 were recreational boat registrations, approximately 35,000 were driver's licence renewals, and 4,700 were senior's card applications. I am advised that only one marine licence application was conducted online. The remainder relate to various other online transactions.

MITSUBISHI MOTORS

In reply to Mr GRIFFITHS (Goyder) (11 October 2010).

The Hon. J.D. HILL (Kaurna—Minister for Health, Minister for Mental Health and Substance Abuse, Minister for the Southern Suburbs, Minister Assisting the Premier in the Arts): I am advised that:

1. By the end of March 2009, 896 retrenched workers had exited Mitsubishi. The Australian and South Australian Governments took decisive action between the initial announcement and those final retrenchments and implemented a range of programs. The key initiatives within the Government's response were transitional assistance for workers, an industry assistance scheme for small businesses and an industry assistance scheme for larger employers.

To mitigate the impact on workers, the South Australian Government launched the \$10 million Mitsubishi Labour Adjustment Package, for which the Australian Government provided \$7.5 million and the State \$2.5 million.

Under the joint package, the Transition Advisory Service provided a range of services to retrenched workers:

- job search skills and techniques
- career counselling/case management/employment brokerage
- recognition of prior learning
- training and licensing
- wage subsidies to assist employers
- relocation assistance within South Australia and interstate
- self employment assistance, including small business training
- other assistance with fares, tools, equipment and fees.

The success of the programs is borne out by the figures. As at May 2010, some 805 Mitsubishi workers, and an additional 144 workers from supply companies, registered for employment advisory services. Of these, 781, or 82 per cent, had been placed in employment.

Eligibility for workers to apply for the assistance ceased in October 2008, however, the provision of services continued beyond that date and workers who did not find work through the assistance package remain eligible for Commonwealth Government job seeker services.

The Department of Further Education, Employment, Science and Technology has ceased monitoring the re-employment arising from the package specifically for Mitsubishi and supplier company workers.

The Office for the Southern Suburbs does not maintain figures on displaced Mitsubishi workers.

UNEMPLOYMENT FIGURES

In reply to Mr GRIFFITHS (Goyder) (11 October 2010).

The Hon. J.D. HILL (Kaurna—Minister for Health, Minister for Mental Health and Substance Abuse, Minister for the Southern Suburbs, Minister Assisting the Premier in the Arts): I have been advised that:

1. Australian Bureau of Statistics Labour Force Survey estimates at the regional level are volatile, largely due to the reduced sample size of the reduced area. For that reason, the Department of Education, Employment and Workplace Relations uses three-month moving averages, and I am quoting from those figures.

For the Southern Adelaide region, the unemployment rate as at September 2010 was 5.2 per cent, compared with 4.4 per cent in September 2009.

The Office for the Southern Suburbs does not maintain unemployment statistics but monitors the figures.

SMALL BUSINESS DEVELOPMENT GRANT

In reply to Mr GRIFFITHS (Goyder) (11 October 2010).

The Hon. J.D. HILL (Kaurna—Minister for Health, Minister for Mental Health and Substance Abuse, Minister for the Southern Suburbs, Minister Assisting the Premier in the Arts): I have been advised that:

1. In the 2010-11 Budget the State Government did not extend the Small Business Development Grant. However, the State Government has provided \$4 million over four years for a

Small and Medium Enterprise Investment Development Program. This program is designed to assist companies to introduce new technology, new products or to enter new markets. The Budget reference is Budget Paper part 2 page 29.

This fund was included in funding for the Department of Trade and Economic Development.

This fund is provided to support the State's manufacturing industries and is not specific to southern Adelaide.

PRIVATE PRACTICE EQUIPMENT FUNDS

In reply to Dr McFETRIDGE (Morphett) (11 October 2010).

The Hon. J.D. HILL (Kaurna—Minister for Health, Minister for Mental Health and Substance Abuse, Minister for the Southern Suburbs, Minister Assisting the Premier in the Arts): I have been advised that:

1. Private practice equipment funds reflect distributions from all relevant types of private practice activities. It is, therefore, not possible to distinguish fund balances derived from private outpatient activity alone.

As at 30 June 2010, funds identified specifically as private practice equipment funds had a balance of \$17 million across SA Health. Health units have identified that a small portion of these funds are already committed to purchases in 2010-11.

BULK BILLING

In reply to Dr McFETRIDGE (Morphett) (11 October 2010).

The Hon. J.D. HILL (Kaurna—Minister for Health, Minister for Mental Health and Substance Abuse, Minister for the Southern Suburbs, Minister Assisting the Premier in the Arts): I have been advised that:

Data on bulk billing practices of specialists are not kept, but that the majority of specialists take the financial circumstances of patients into account when determining individual patient charges. Patients are entitled to seek advice on charges prior to consultation.

HEALTH, NON-OPERATING FUNDS

In reply to Dr McFETRIDGE (Morphett) (11 October 2010).

The Hon. J.D. HILL (Kaurna—Minister for Health, Minister for Mental Health and Substance Abuse, Minister for the Southern Suburbs, Minister Assisting the Premier in the Arts): Response by Chief Executive of the Department of Health on 11 October 2010:

'Yes, as the Minister said, we have progressively improved the controls around non-operating funds over the last two or three years. Clearly, as Mr O'Connor said, there are some residual practices that are not in accordance with our own policies. The officer concerned has been formally counselled and the matter fixed (my emphasis). As the Minister said, there has been no loss of public funds and the funds have been returned to the nonoperating fund and will be used in accordance with the requirements of that particular non-operating fund.

When we first set about improving the procedures for non-operating funds, there was a great deal of concern because people were using them as virtual individual slush funds and we have totally removed that practice. This was a different matter. It was sloppy work and the person who did it will be held to account for it, but across the system the non-operating funds are managed in a far more accountable manner than they ever had been in the past.'

Further response:

This statement was based on verbal advice received in the chamber from the Executive Director, Finance and Administration, Department of Health.

The Chief Executive has now received advice from the Director, Corporate Finance that he was incorrectly advised during Estimates with regards to the statement 'that the officer/s concerned had been formally counselled'.

A letter was sent to the officers involved on 18 October 2010 and they were formally counselled on Thursday, 21 October 2010.

Ms PORTOLESI (Hartley—Minister for Aboriginal Affairs and Reconciliation, Minister for Multicultural Affairs, Minister for Youth, Minister for Volunteers): The departmental Ministerial Liaison Officers (MLOs) located in my office do not form part of the full-time ministerial staff listed in Budget Paper 4, Portfolio Statement 1.

ABORIGINAL COMMUNITY ASSISTANCE FUNDING

In reply to Dr McFETRIDGE (Morphett) (12 October 2010).

Ms PORTOLESI (Hartley—Minister for Aboriginal Affairs and Reconciliation, Minister for Multicultural Affairs, Minister for Youth, Minister for Volunteers): I advised the committee that the Chief Executives Group on Aboriginal Affairs (CEGAA) visited Amata and Mimili on the Anangu Pitjantjatjara Yankunytjatjara (APY) Lands.

I have since been advised that the visit to the APY Lands was undertaken by the. Senior Management Council (SMC). The SMC prepared a report which was taken to CEGAA. The outcomes were also incorporated into the local implementation plans (LIPs) for Amata and Mimili.

A formal response to this question will be provided to the committee for the Hansard supplement.

ABORIGINAL COMMUNITY ASSISTANCE FUNDING

In reply to **Dr McFETRIDGE (Morphett)** (12 October 2010).

Ms PORTOLESI (Hartley—Minister for Aboriginal Affairs and Reconciliation, Minister for Multicultural Affairs, Minister for Youth, Minister for Volunteers): Dr McFetridge made reference to Aboriginal community assistance funding being reduced from \$4.2 million to \$1.8 million (Hansard Estimates Committee A, page 290).

Aboriginal community assistance is a Grants and Subsidies budget line title in the Auditor-General's report that is a consolidation of all grants and subsidies across the portfolios within the Department of the Premier and Cabinet (DPC), which includes Aboriginal Affairs and Reconciliation Division (AARD) grants.

Rather than being an AARD program that has been reduced, it is a budget line description in the Auditor-General's report that captures a range of specific grants across DPC.

ABORIGINAL COMMUNITY ASSISTANCE FUNDING

In reply to Dr McFETRIDGE (Morphett) (12 October 2010).

Ms PORTOLESI (Hartley—Minister for Aboriginal Affairs and Reconciliation, Minister for Multicultural Affairs, Minister for Youth, Minister for Volunteers): Dr McFetridge made reference to the Aboriginal community services assistance funding being reduced from \$2.9 million in 2008-09 to \$3 in 2009-10.

Aboriginal community essential services assistance is a Grants and Subsidies\$ budget line title in the Auditor-General's report that is a consolidation of all grants to Aboriginal communities and organisations for operating and maintaining community infrastructure. These are AARD's infrastructure services grants for providing specific operational services (not community assistance grants).

In 2008-09, AARD entered into a Grant Agreement with Regional Anangu Services (RAS) an external service provider, to manage and operate the power on the APY Lands, including the Central Power Station at Umuwa.

This required RAS to purchase the fuel and employ staff to operate the stations and off-set costs through electricity billing of consumers and claiming Commonwealth fuel rebates. AARD provided supplementary funding of \$2 million under this Grant Agreement in 2008-09.

However, in 2009-10 AARD assumed direct responsibility for managing power stations and incurring costs under the expenditure category of Supply Services (reflected on page 968 of the Auditor-General's report which indicate under Community Infrastructure, Supplies and Services has increased from \$ million in 2008-09 to \$5 million in 2009-10).

Therefore, there has been no reduction in essential services expenditure, rather a reclassification of expenses from Grants to Supplies and Services.

SETTLEMENT SERVICES FOR HUMANITARIAN ENTRANTS

In reply to Mrs REDMOND (Heysen—Leader of the Opposition) (12 October 2010).

Ms PORTOLESI (Hartley—Minister for Aboriginal Affairs and Reconciliation, Minister for Multicultural Affairs, Minister for Youth, Minister for Volunteers): In response to a question (Hansard Estimates Committee A, page 272), I advised the committee that Sophia Poppe had been appointed to gather data on settlement services provided to humanitarian entrants in South Australia.

I have since been advised that in late 2009 and early 2010, Multicultural SA engaged a contractor, Alina Lebed, to gather the data on settlement services provided to humanitarian entrants. This data will soon be available on the Multicultural SA website.

The Government appointed Sophia Poppe as the Director of Settlement Services for Humanitarian Entrants in April this year and she has been consulting very extensively with people in the sector.

GRANTS AND SUBSIDIES

In reply to Mrs REDMOND (Heysen—Leader of the Opposition) (12 October 2010).

Ms PORTOLESI (Hartley—Minister for Aboriginal Affairs and Reconciliation, Minister for Multicultural Affairs, Minister for Youth, Minister for Volunteers): I can advise that Grants and Subsidies revenue has reduced to zero in 2010-11 due to the termination of an agreement to fund an executive assistant to the Honorary Consuls in South Australia.

The change in Commonwealth revenue from \$125,000 in 2008-09 to \$18,000 in 2010-11 relates to a two year funding initiative, Targeted Skills Needs in Regions. In 2008-09, \$106,000 was received as Commonwealth revenue and in 2009-10 \$293,000 (including a carryover of \$39,000 from 2008-09) was received as appropriation.

GRANTS AND SUBSIDIES

In submitting this information, it is important to note it is widely recognised that the Task Force model of creating a central funding pool managed by the Department of the Premier and Cabinet's Aboriginal Affairs and Reconciliation Division has been highly successful in delivering specific and targeted services and programs to improve the health and wellbeing of Aboriginal people and families on the APY Lands.

A clear example of the benefits of the program, is the reduction in the prevalence of petrol sniffing. The 2006 Nganampa survey of petrol sniffing on the APY Lands reported a 60 per cent reduction in the incidence of petrol sniffing across the Lands. A further 54 per cent reduction was reported in 2007 (from the cases still remaining from 2006). In 2008, the survey identified a further 47 per cent reduction, indicating a total 90 per cent reduction in the number of petrol sniffing cases over 3 years.

A key to this success is the pooling of funding that provides the flexibility to direct resources, as required, to the highest and most immediate service needs on the Lands.
