NON-GOVERNMENT SCHOOLS, FUNDING

In reply to Mr PISONI (Unley) (7 October 2010).

The Hon. J.W. WEATHERILL (Cheltenham—Minister for Education, Minister for Early Childhood Development): This final funding figure for non-government schools in 2010-11 is not yet available, and can only be finalised when adjustments have been made to the budget figure to reflect:

- Treasury inflation rate on goods and services; and
- an adjustment for salary movements; and
- adjustment for increase/decrease in student numbers in non-government schools.

ROSE PARK PRIMARY SCHOOL

In reply to Mr PISONI (Unley) (7 October 2010).

The Hon. J.W. WEATHERILL (Cheltenham—Minister for Education, Minister for Early Childhood Development): An exemption from attendance at school for the students at the Family Unit was never issued by the Minister under the provision of section 81A. As no exemption was granted, such an exemption is not still in place.

During the time in which the department was considering governance arrangements for the Family Unit, the then Chief Executive wrote to the school community stating that the department would provide the students of the Family Unit with an exemption from attendance at Rose Park Primary School under the provisions of Section 81A (if necessary). This advice was made on the basis that the children would continue to be enrolled at Rose Park Primary School but be exempted for attendance at that school while they attended at the Family Unit. However, those arrangements did not occur and as such the use of an exemption under the section was not necessary.

During term 4, 2009 DECS entered an agreement with the Parkside Primary School for the Family Unit students to be enrolled at that school. This action was subsequently undertaken and for 2010, the Family Unit students have been enrolled at the Parkside Primary School whilst remaining physically at the Family Unit. The Parkside Primary School Principal is currently the Head Teacher under the provisions of the Education Act for the Family Unit students and for all intents and purposes, the Family Unit students are considered to be students at the Parkside Primary School attending at an outreach of that school.

SOUTH ROAD

In reply to Mr GRIFFITHS (Goyder) (7 October 2010).

The Hon. P.F. CONLON (Elder—Minister for Transport, Minister for Infrastructure, Minister for Energy): I have been advised:

To the end of October 2010, \$15.741 million had been spent on South Road planning. This includes the South Road Superway project for which construction will commence in February 2011, and the Darlington Transport Study which is currently out for community consultation and nearing completion.

SOLAR HOT WATER REBATE SCHEME

In reply to Mr WILLIAMS (MacKillop—Deputy Leader of the Opposition) (7 October 2010).

The Hon. P.F. CONLON (Elder—Minister for Transport, Minister for Infrastructure, Minister for Energy): I have been advised:

The South Australian solar hot water rebate scheme currently provides a \$500 rebate to low income households to help them meet the requirements of South Australia's water heater installation requirements that were introduced on 1 July 2008.

In the 2010-11 State Budget, the Treasurer announced that as a budget savings measure, the state solar hot water rebate will finish on 30 June 2013.

While no specific modelling was done on the impact of closing the solar hot water rebate scheme, modelling was done prior to the introduction of the water heater standards in July 2008 that indicated that the higher capital cost is subsequently paid back by reduced running costs. DTEI also provided me with details on the number of rebates paid since the program began plus the relative costs of various types of complying hot water systems.

COOBER PEDY AREA SCHOOL PRINCIPAL

In reply to Mr PISONI (Unley) (7 October 2010).

The Hon. J.W. WEATHERILL (Cheltenham—Minister for Education, Minister for Early Childhood Development): As at 24 September 2010 the total cost is \$64,431.

This amount includes salary difference between Principal PCO6 and Principal PCO8, accommodation, meals, and flights.

PREMIER'S BE ACTIVE CHALLENGE

In reply to Mr PISONI (Unley) (7 October 2010).

The Hon. J.W. WEATHERILL (Cheltenham—Minister for Education, Minister for Early Childhood Development): A list of schools receiving grant funding together with the amount received is provided below.

Schools were expected to use these funds for staff release time to attend professional development related to physical activity; to purchase physical activity equipment or resources; or for professional services or support for physical activity.

The schools that were awarded \$385 received their funding in recognition of their involvement in the Premier's *be active* Challenge. The schools that received \$500 were also involved in the *eat well be active* Primary Schools project.

The number of SL200 buses in operation in the bus fleet is 26.

BRIDGE MAINTENANCE AND REPAIR

The Hon. P.F. CONLON (Elder—Minister for Transport, Minister for Infrastructure, Minister for Energy): I have been advised:

The expenditure on bridge maintenance and rehabilitation varies from year to year depending upon the level of investing expenditure on rehabilitation and replacement in any one year. Funds for bridge maintenance, rehabilitation and replacement are allocated from a number of investing and operation budget lines including specific investing project allocations, the Transport

PUBLIC SECTOR LEAVE ENTITLEMENTS

In reply to Mr PISONI (Unley) (7 October 2010).

The Hon. J.W. WEATHERILL (Cheltenham—Minister for Education, Minister for Early Childhood Development): This question has been answered by the Treasurer—see Hansard of 30 September 2010, page 1552.

RAIL REVITALISATION

In reply to Mr GRIFFITHS (Goyder) (7 October 2010).

The Hon. P.F. CONLON (Elder—Minister for Transport, Minister for Infrastructure, Minister for Energy): I have been advised:

Expenditure of \$4.846 million (this incorporates under-expenditure from 2008-09) was allocated in 2009-10 as a part of the Port Adelaide Viaduct upgrade project. A total of \$27.658 million was spent on the Port Adelaide Viaduct upgrade in 2009-10. The timing of this expenditure was coordinated with other expenditure for track upgrade, station upgrade and other bridge works on the Port Adelaide Viaduct and on the Outer Harbor line. This coordination was aimed at maximising the benefits of the necessary closure of part of the Outer Harbor line.

In addition to the above, but funded from the *Rail Revitalisation—upgrade of infrastructure* and equipment—bridges program, approximately \$1.0 million has been spent in 2009-10 and 2010-11 on upgrading of the Gawler line bridge over the River Torrens.

LITERACY AND NUMERACY NATIONAL PARTNERSHIP

In reply to Mr GARDNER (Morialta) (7 October 2010).

The Hon. J.W. WEATHERILL (Cheltenham—Minister for Education, Minister for Early Childhood Development): The complete list of 55 schools that have benefit from the Literacy and Numeracy National Partnership (LNNP) and additional Department of Education, Employment and Workplace Relations funding is attached.

The Group A schools have had a full time equivalent coach from August 2009 until the end on term 4 2010. It is intended to extend these positions in the 31 schools for term 1 2011 and a recruitment process is currently underway.

Group B schools were the additional six DEEWR identified LNNP schools with separate total funding of \$600,000 provided to place a coach from April 2010 to the end of term 4 2010 in those schools. Schools listed in brackets in this group are additional partner schools also receiving some benefit from the resource.

Group C schools were identified by regional leadership as schools that would benefit from support from a coach. 18 of our existing coaches work for two days per week in these Partner Schools to extend the benefits of coaching from their initial school to a neighbouring school. It is hoped that this arrangement will stimulate cluster work on literacy and numeracy improvement.

EVEN START PROGRAM

In reply to Mr GARDNER (Morialta) (7 October 2010).

The Hon. J.W. WEATHERILL (Cheltenham—Minister for Education, Minister for Early Childhood Development): National benchmarks have not existed since the introduction of the NAPLAN in 2008.

It could be considered that a comparable group in 2009 might have been the students below the National Minimum Standard (NMS) in the NAPLAN Assessments given a student below the NMS has typically not demonstrated the basic elements of Literacy and Numeracy to participate at their year level.

In 2009, there were 7,772 students below national minimum standard in one or more of the following elements: reading, writing and numeracy out of a total of 56,758 students for years 3, 5 and 7.

LITERACY AND NUMERACY NATIONAL PARTNERSHIP

In reply to Mr GARDNER (Morialta) (7 October 2010).

The Hon. J.W. WEATHERILL (Cheltenham—Minister for Education, Minister for Early Childhood Development):

How were the 31 schools selected?

Selection of schools to benefit for the Literacy and Numeracy National Partnership funding was an evidence-driven process.

Officers from the Department of Education and Children's Services analysed the state Literacy and Numeracy (LAN) testing data from 2006-07 and the national NAPLAN test results from 2008. From this analysis a shortlist of schools that would benefit from coaching intervention by a teacher with specialist knowledge of literacy or numeracy improvement was developed. It was determined that this list would comprise of schools generally not identified in the Communities Making a Difference National Partnership (also referred to as the Low SES School Communities National Partnership) providing resources to a wider number of schools.

This shortlist was provided to regional directors who, using their in-depth knowledge of the strategic directions and challenges facing these schools, made the final decisions about which schools in their regions would be finally included in the coaching program. In terms of sharing expertise across schools, coaches have partnered with a nearby school particularly in the provision of professional learning in data analysis, pedagogy, teaching programs and targeted interventions.

Support for students falling behind in literacy

To support literacy and numeracy improvement, schools use a coherent whole of school approach to the teaching of literacy and numeracy. In addition, schools analyse literacy and numeracy student achievement data such as NAPLAN and other diagnostic measures to strategically inform and support the literacy and numeracy needs of students particularly those in need of support.

Students who achieved below the national minimum standard in these tests will be supported through their individual learning plans, which ensures ongoing targeted support at the school.

In 2009 the Literacy Secretariat was formed to promote high quality literacy teaching, learning and leadership by coordinating and supporting a focused approach to literacy improvement birth to year 12 for sites and regions.

In addition, the Government has committed to the establishment by 2012 of mandatory weekly teaching times for primary school students in literacy.

In 2010 to support a whole school literacy and numeracy approach ,a range of grants were grouped together for each school into a Single Literacy and Numeracy allocation. This allowed schools to clearly identify the quantum of resources available for literacy and numeracy both for the whole school approach and targeted support. Included in this funding are grants to support students with learning difficulties.

The Principals as Literacy Leaders (PALL) program further assists principals to lead an effective whole school approach to literacy as well as support them identify and implement evidence based interventions and strategies for those students in need of support.

TAFE CHILDCARE CENTRES

In reply to Mr PISONI (Unley) (7 October 2010).

The Hon. J.W. WEATHERILL (Cheltenham—Minister for Education, Minister for Early Childhood Development): I am advised that the two childcare centres of O'Halloran Hill and Panorama have a low rate of utilisation, and that the majority of users are not staff or students of the TAFEs.

There are many other Long Day Care facilities within 5 kilometres of the two sites. I am advised that there are 31 Long Day Care Centres within 5 kilometres of the Panorama Child Care Centre and 20 Long Day Care Centres within 5 kilometres of the O'Halloran Hill Child Care Centre.

A Children's Centre for Early Childhood Development and Parenting is also located nearby at Forbes Primary School, and a new Children's Centre is being constructed at Darlington.

RESPITE CARE PROGRAM

In reply to Mr PISONI (Unley) (7 October 2010).

The Hon. J.W. WEATHERILL (Cheltenham—Minister for Education, Minister for Early Childhood Development): The Respite care program will continue to be administered by DECS.

PRISON ACCOMMODATION

In reply to Mr GOLDSWORTHY (Kavel) (8 October 2010).

The Hon. A. KOUTSANTONIS (West Torrens—Minister for Industry and Trade, Minister for Correctional Services, Minister for Gambling): I am advised that a breakdown of the \$32.267 million for additional prisoner accommodation is provided in the following table. Capital payments include not only the costs of the beds but a range of associated infrastructure works. Cash flows incurred for the cost of the beds and the associated infrastructure are shown in the year they were incurred. Consequently, costs in a given year do not always directly relate to the beds commissioned in that year.

contingency budget and not shown against the Department for Correctional Services' project line at this stage; funds will be transferred to the Department for Correctional Services when the specific detailed proposal is approved by Cabinet.

5. The 2009-10 Capital Investment statement reported 446 beds as being provided. In addition to the 446 beds, there are the 12 beds at the Adelaide Women's Prison (refer to note 2), 10 beds at Mount Gambier Prison (refer to note 3), 14 beds at Port Augusta Prison in 2009-10 not included as part of the original 2009-10 budget, and 80 beds at Port Augusta Prison approved as part of the 2010-11 Budget.

Mr RAU (Enfield—Attorney-General, Minister for Justice, Minister for Tourism): I have received this advice:

For 2010-11, \$479,000 relates to the Community Protection Panel.

PRISON ACCOMMODATION

In reply to Mr VAN HOLST PELLEKAAN (Stuart) (8 October 2010).

The Hon. A. KOUTSANTONIS (West Torrens—Minister for Industry and Trade, Minister for Correctional Services, Minister for Gambling): I am advised that in the 2009-10 Capital Investment Statement, the Prisons—Additional Accommodation major project line indicated an estimated total cost of \$15.521 million (for 446 beds).

The increase of \$16.746 million (to the \$32.267 million reported in the 2010-11 Capital Investment Statement) relates to \$16.2 million for the Port Augusta Prison 80 bed cell block, and \$546,000 for the cost of one Project Manager (and associated costs) for the Port Lincoln Prison, Port Augusta Prison and Mount Gambier Prison projects over three years.

The costs associated with the Port Lincoln Prison low security unit were already included in the budget estimates at the time of the 2009-10 budget.

A budget for the Mount Gambier Prison expansion has not yet been provided to the Department for Correctional Services. A provision is held centrally by the Department of Treasury and Finance and a budget will be provided to the Department for Correctional Services when a specific proposal is finalised and approved by Cabinet.

BUILDING COMMUNITIES DIVISION

In reply to Ms CHAPMAN (Bragg) (8 October 2010).

Mr RAU (Enfield—Attorney-General, Minister for Justice, Minister for Tourism): I have received this advice:

The Attorney-General's Department is currently undertaking a reorganisation exercise with a high-level design near finalisation.

There is no intention to change the role or function of the Native Title Claim Resolution Unit. The planned redesign will see the Unit's administrative reporting line shift to the revised Building Communities Division. The Building Communities Division aggregates those areas across the Attorney-General's Department with a significant community focus.

It is important to note that the Native Title Resolution Unit will continue to work closely with the Crown Solicitor's Office.

LIQUOR AND GAMBLING APPROVALS

In reply to Mr GRIFFITHS (Goyder) (8 October 2010).

The Hon. A. KOUTSANTONIS (West Torrens—Minister for Industry and Trade, Minister for Correctional Services, Minister for Gambling): I am advised that each application is treated on its merits and the average timeframe for an application from a person who has not been approved previously, is six weeks providing that all documentation has been supplied, fingerprints have been taken and there are no fit and proper person issues.

There are applications that are still underdetermined and beyond the control of the Liquor and Gambling Commissioner. Delays in processing applications occur when the application forms are incomplete, or when applicants fail to undertake fingerprinting in a timely manner. Applicants are advised of this requirement at the time of lodging the application.

The Office of the Liquor and Gambling Commissioner (OLGC) actions all new applications within five business days of receipt, by either contacting the applicant for more information or forwarding the application to South Australia Police. This process ensures that the applicant is a fit and proper person, as required by the Gaming Machines Act 1992.

The OLGC does not report on the average time taken for applications.

MINISTERIAL STAFF

In reply to Ms CHAPMAN (Bragg) (8 October 2010).

Mr RAU (Enfield—Attorney-General, Minister for Justice, Minister for Tourism): I have received this advice:

As of 30 June, 2010, there are 6.6 FTE's located in the Attorney-General's Office that are funded from other sources.

OFFICE OF THE DIRECTOR OF PUBLIC PROSECUTIONS

In reply to Ms CHAPMAN (Bragg) (8 October 2010).

Mr RAU (Enfield—Attorney-General, Minister for Justice, Minister for Tourism): | have received this advice:

During 2009-10, 2.5 FTE's were transferred to the Serious and Organised Crime Unit from the Office of the Director of Public Prosecutions(ODPP).

This reduced the 2009-10 budgeted FTE's from 148.38 FTE's to 145.88 FTE's.

BUILDING COMMUNITIES DIVISION

In reply to Ms CHAPMAN (Bragg) (8 October 2010).

Mr RAU (Enfield—Attorney-General, Minister for Justice, Minister for Tourism): | have received this advice:

The overall timeframe target for the finalisation of a complaint will vary according to the level of enquiry or investigation the Police Complaints Authority (the Authority) considers appropriate for the complaint. The three principal levels of enquiry or investigation are: Conciliation, Preliminary Investigation, and Full Investigation. The following timeframe targets apply.

Conciliations

Where a complaint is referred to the Internal Investigation Section for Conciliation the timeframe target for the return of the file to the Authority is four weeks (28 days).

Therefore the overall timeframe target for receipt of the complaint until it is finalised by the Authority is 28 + 28 days, that is 56 days.

Preliminary Investigations

Where a complaint is referred to the Internal Investigation Section for Preliminary Investigation the timeframe target for the return of the file to the Authority is five weeks (35 days).

The overall timeframe target for a complaint that can be finalised on the basis of a Preliminary Investigation is 35 + 28 days, that is 63 days.

Full Investigations

Where a complaint is referred to the Internal Investigation Section for Full Investigation the timeframe target for the return of the file to the Authority is 12 weeks (84 days).

The overall timeframe target from receipt of complaint until it is finalised following a Full Investigation is 84 + 28 days, that is 112 days.

FIERA DEL LEVANTE

In reply to Mr HAMILTON-SMITH (Waite) (8 October 2010).

The Hon. A. KOUTSANTONIS (West Torrens—Minister for Industry and Trade, Minister for Correctional Services, Minister for Gambling): I have been advised of the following:

DTED expenditure on Fiera del Levante since 2007 is anticipated to be \$1.143m. Costs for the 2010-11 event are subject to exchange rate fluctuations on final invoices.

LANDFILL

In reply to Mr PEDERICK (Hammond) (11 October 2010).

The Hon. P. CAICA (Colton—Minister for Agriculture, Food and Fisheries, Minister for Industrial Relations, Minister for Forests, Minister for Regional Development):

1. The estimated reduction target in waste to landfill in 2008-09 was 35,000 tonnes and the actual result achieved in 2008-09 was 57,100 tonnes. Data indicates that in the same year, there was also a decrease in the total waste generated in South Australia which may be attributed to the global financial crisis. In 2008-09, the total waste generated decreased by 116,047 tonnes compared with 2007-08, in spite of population growth. However, total waste generated in the two previous financial years (2006-07 and 2005-06) had increased by 162,657 and 25,050 tonnes, respectively.

Total annual tonnages of waste to landfill during 2009-10 was 1,035,172 tonnes. The 2009-10 target reduction of 35,000 tonnes in waste to landfill was surpassed by an actual result of 41,000.

PARK ENTRANCE FEES

In reply to Mr WILLIAMS (MacKillop—Deputy Leader of the Opposition) (11 October 2010).

The Hon. P. CAICA (Colton—Minister for Agriculture, Food and Fisheries, Minister for Industrial Relations, Minister for Forests, Minister for Regional Development): I am advised that:

1. The revenue measures referred to does not solely relate to entrance fees. A variety of measures have been identified to generate additional net income from commercial activities undertaken within the parks system or through increases in cost recovery. These measures include:

- undertaking site specific marketing of key parks to increase the number of visitors;
- introducing an on-line booking system for heritage accommodation within parks to increase utilisation rates;
- ensuring appropriate commercial returns from lessees for the use of parks and/or infrastructure;
- implementing entrance fee pricing that reflects improved park infrastructure and visitor experiences; and
- progressive introduction of cost-reflective pricing for guided and un-guided tours within commercial sites.

Price increases will contribute to the cost of refurbishments and ongoing maintenance and will reflect the increase in the value of the experience.

All cars entering the majority of National Parks and Reserves are currently subject to a park entry fee. These fees are revised annually and are subject to price increases based on a Government approved escalation rate that takes effect from 1 July.

Entrance fees at a small number of National Parks (Belair, Innes, Lincoln) will be considered for future price increases. Many of South Australia's high visitation parks have undergone multi-million dollar refurbishments to enhance the equality of visitor experiences and improve access.

The park entry fee for a single vehicle at Belair, Innes and Lincoln National Parks was \$8.00 in 2009-10. It was increased to \$8.50 in 2010-11.

2. It is estimated that there are about 750,000 paying visitors to South Australian National Parks each year.

WATER PROJECT COSTS

In reply to Mr WILLIAMS (MacKillop—Deputy Leader of the Opposition) (11 October 2010).

The Hon. P. CAICA (Colton—Minister for Agriculture, Food and Fisheries, Minister for Industrial Relations, Minister for Forests, Minister for Regional Development): I am advised that:

Bird In Hand WWTP Upgrade

The approved Bird In Hand wastewater treatment plant upgrade requires capital expenditure of \$60 million to be incurred from 2009 to 2014. SA Water's approved 2009-10 capital

budget included an allocation of \$35.5 million from 2009 to 2013 for this project with these estimated costs based on early concepts.

An extensive consultation process implemented for this project allowed input from community groups, local residents and government agencies thus ensuring that all stakeholder values were managed. As well, the application of an Early Contractor Involvement (ECI) process during the development phase required refinement of the project costs estimate, construction schedule and risks, and identified the need for an increased project budget.

Bolivar

The original approved budget was based on an early concept, prior to any option being selected. The preferred option adopted included an upgrade to the pump station with additional capacity to meet system growth in the future.

The original scope of the project has increased during the options development and the commencement of detailed design phases which have impacted on the original estimate.

Augmentation of the Middle River Water Supply System

The original approved budget of \$10 million was prepared based on an early feasibility study for the Storage upgrade with no site yet identified.

However, with the draft concept design now nearly complete and a valuation for the land acquisition of the preferred site undertaken, a further refinement of the cost estimate was possible in line with the identified technical and commercial risks associated with the project. The current estimate is \$20.3 million.

The preferred site is on a slope and close to residential properties. This has added additional costs due to additional earthworks and sound proofing of the buildings.

When investigating the concept design, the mode of disinfection of the water has been recommended to be changed. This will allow more consistent compliance with the Department of Health requirements, but also increase the estimated costs.

POLICE CALL CENTRE AND COMMUNICATIONS BRANCH

In reply to Mr GOLDSWORTHY (Kavel) (12 October 2010).

The Hon. M.J. WRIGHT (Lee—Minister for Police, Minister for Emergency Services, Minister for Recreation, Sport and Racing): The South Australia Police has provided the following information:

Implementation of the increase in the SAPOL establishment of 313 positions over four years will commence in 2010-11 and conclude in July 2014. A review of the Call Centre and Communications Branch is currently being undertaken. It is expected that this review will make recommendations in relation to staffing levels.

While no variation to full-time equivalent numbers is budgeted for the Call Centre or Communications Branch for the current financial year (2010-11) at this time, staffing levels may vary in the current year depending on the outcome of the review.

POLICE CALL CENTRES

In reply to Mr GOLDSWORTHY (Kavel) (12 October 2010).

The Hon. M.J. WRIGHT (Lee—Minister for Police, Minister for Emergency Services, Minister for Recreation, Sport and Racing): The South Australia Police have provided the following information, calculated on the hourly average for the 2009-10 fiscal year.

The highest hourly average for 131 444 Police Assistance calls answered within 10 seconds is recorded as follows:

- Night shift (between 11pm and 7am) between 6am and 7am, 95.03 per cent of calls answered within 10 seconds.
- Day shift (between 7am and 3pm) between 7am and 8am, 90.91 per cent of calls answered within 10 seconds.
- Afternoon shift (between 3pm and 11pm) between 8pm and 9pm, 93.66 per cent of calls answered within 10 seconds.

The lowest hourly average for 131 444 Police Assistance calls answered within 10 seconds is as follows:

- Night Shift between midnight and 1am, 92.98 per cent of calls answered within 10 seconds.
- Day shift between 2pm and 3pm, 87.82 per cent of calls answered within 10 seconds.
- Afternoon shift between 3pm and 4pm, 86.16 per cent of calls answered within 10 seconds.

POLICE ASSISTANCE TASKINGS

In reply to Mr GOLDSWORTHY (Kavel) (12 October 2010).

The Hon. M.J. WRIGHT (Lee—Minister for Police, Minister for Emergency Services, Minister for Recreation, Sport and Racing): South Australia Police have provided the following information in relation to police assistance taskings for the period 1 July 2009 to 30 June 2010:

- Total number of Category A taskings is 109,445
- Total number of Category B taskings is 330,654
- Total number of Category C taskings is 55,833

BROADBAND BLACKSPOTS

In reply to Mr HAMILTON-SMITH (Waite) (13 October 2010).

The Hon. J.J. SNELLING (Playford—Minister for Employment, Training and Further Education, Minister for Science and Information Economy, Minister for Road Safety, Minister for Veterans' Affairs): The most common form of broadband access in Australia today is the service known as Asymmetric Digital Subscriber Line or ADSL which is delivered via the common telephone line. An estimated 10 per cent of residential, commercial and industrial properties in metropolitan Adelaide are unable to access this type of service. The telephone lines connecting these premises to the local telephone exchange do not provide a unique continuous copper cable, a necessary condition for the delivery of ADSL broadband.

The premises experiencing this problem are scattered throughout the metropolitan area in more than 350 separate blackspots, each consisting of multiple premises. The blackspots vary in size from over 1,000 premises down to 100 premises.

In general, the more recently developed suburban areas have a disproportionately larger number of affected premises. Hence the problem is most evident in the southern and northern areas.

At the time that the Government of South Australia sought a solution through the release of a Request for Proposals from the telecommunications industry, the count of blackspot premises by local government area showed that almost 80 per cent were located in six areas:

The Adelaide Metropolitan Broadband Blackspots project which DFEEST has funded in partnership with Adam Internet will resolve over 90 per cent of the blackspots in the above areas.

THEBARTON BIOSCIENCE PRECINCT

In reply to Mr HAMILTON-SMITH (Waite) (13 October 2010).

The Hon. J.J. SNELLING (Playford—Minister for Employment, Training and Further Education, Minister for Science and Information Economy, Minister for Road Safety, Minister for Veterans' Affairs): The 49,000 square metre Thebarton Bioscience Precinct was purchased by Government at a cost of about \$6 million, including demolition and remediation. All site works have been completed and the land is environmentally audited as suitable for commercial/industrial development.

The BioSA Business Incubator was completed in 2008 at a cost of \$12.1 million. The building was fully leased to early stage biotech companies prior to completion and there is currently no vacant space in the building.

Two parcels of vacant land in the precinct, totalling 20,000 square metres, are available for sale. Subdivision by Community Title will ensure the land is only developed for 'commercial bioscience and associated industry facilitators.' No land has been sold to date.

PREMIER'S SCIENCE AND RESEARCH COUNCIL

In reply to Mr HAMILTON-SMITH (Waite) (13 October 2010).

The Hon. J.J. SNELLING (Playford—Minister for Employment, Training and Further Education, Minister for Science and Information Economy, Minister for Road Safety, Minister for Veterans' Affairs): The Premier's Science and Research Council generally meets quarterly. In 2009, three Council meetings were held—in August, September and December 2009. The meeting scheduled for March 2010 was cancelled due to the State Government election held that month. Since the election, there have been two meetings of the Council. I attended the meeting of 23 September, 2010.

The Premier and the former Minister for Science and Information Economy were apologies for the three meetings held in 2009; however, the Chief Scientist (who chairs the Council) briefs the Premier and the Minister on matters discussed and advice provided by the Council. In addition, a policy adviser from the Premier's Office attends Council meetings and maintains close liaison with the Chief Scientist.

In relation to the question concerning the cost of maintaining support to the Council, total expenditure incurred in 2009-10 to support the Council and the Chief Scientist was \$293,887 which includes the following components:

Note that the role of Secretariat staff extends beyond support to the Council and the Chief Scientist; they also contribute to the broader activities of the Science and Information Economy Directorate of DFEEST.

VOCATIONAL EDUCATION AND TRAINING

In reply to Mr PISONI (Unley) (13 October 2010).

The Hon. J.J. SNELLING (Playford—Minister for Employment, Training and Further Education, Minister for Science and Information Economy, Minister for Road Safety, Minister for Veterans' Affairs): The South Australian 2006 equivalent cost per hour figure is \$17.11 and the 2009 figure is \$14.20 (in 2009 dollar terms). This shows a 17 per cent fall.

It should be noted, however, that in 2009 changes were made to the methodology for calculating the cost of VET and the scope of data used in this calculation.

The 2006 equivalent cost per hour figures, in 2009 dollar terms, for the national average and the other states and territories, are not publicly available until late December 2010.

HEALTH PORTFOLIO

In reply to Dr McFETRIDGE (Morphett) (13 October 2010).

The Hon. J.J. SNELLING (Playford—Minister for Employment, Training and Further Education, Minister for Science and Information Economy, Minister for Road Safety, Minister for Veterans' Affairs): The Minister for Health has advised that:

1. The Sustainable Budget Commission (SBC) process was subject to Cabinet requirements.

2. The overall intention of the Healthy Food and Drink Choices for Staff and Visitors in SA Health Facilities policy is to work towards increasing healthier food and drink options whilst restricting less healthy options for staff, patients and visitors.

The policy allows for up to 20 per cent of the food and drinks displayed to come from RED category items, which includes lollies, chocolates and other confectionary.

3. The Smoke-Free Health Services policy is designed to protect people from passive smoking. Many of the people who stay in, or visit our hospitals are particularly vulnerable to passive smoking, such as veterans with pre-existing respiratory conditions.

The implementation of the new policy at the Repatriation General Hospital has gone well.

PLAYFORD CAPITAL

In reply to Mr HAMILTON-SMITH (Waite) (13 October 2010).

The Hon. J.J. SNELLING (Playford—Minister for Employment, Training and Further Education, Minister for Science and Information Economy, Minister for Road Safety, Minister for Veterans' Affairs): I am advised that the independent Report on Playford contains material that is commercially sensitive and commercial-in-confidence in relation to third parties, and so it is inappropriate for me to release the Report at this time.

PLAYFORD CAPITAL

In reply to Mr HAMILTON-SMITH (Waite) (13 October 2010).

The Hon. J.J. SNELLING (Playford—Minister for Employment, Training and Further Education, Minister for Science and Information Economy, Minister for Road Safety, Minister for Veterans' Affairs): I am advised there are four staff within Playford Capital on salaries of \$100,000 or more.

ROAD FATALITIES

In reply to Mr GOLDSWORTHY (Kavel) (13 October 2010).

The Hon. J.J. SNELLING (Playford—Minister for Employment, Training and Further Education, Minister for Science and Information Economy, Minister for Road Safety, Minister for Veterans' Affairs): The latest statistics quoted on 13 October, 2010, of blood alcohol levels of drivers and riders killed on South Australian roads have since been updated. The most recent data to date includes fatalities up to 30 June, 2010.

In the 12 months ending 30 June, 2010, 25 of the 73 (or 34 per cent) drivers and riders killed, who were tested for blood alcohol concentration had an illegal limit of .05 blood alcohol concentration, or above.

The blood alcohol concentration for fatalities is supplied directly from Forensic Science SA.

ADVISORY BOARD OF AGRICULTURE

In reply to **Mr VENNING (Schubert)** (13 October 2010).

The Hon. M.F. O'BRIEN (Napier—Minister for Agriculture, Food and Fisheries, Minister for Forests, Minister for Regional Development, Minister for the Northern Suburbs): The Advisory Board of Agriculture has performed two functions: one to provide advice to the Minister, and the second one as the governing body for the Agricultural Bureau movement.

A new proposition is currently being developed that, in palce of the Food Council and a large number of advisory boards, including the Advisory Board of Agriculture, a new body, possibly called the 'Agribusiness and Seafood Council' or similar will be formed.

This new Council will have a more clearly defined role with a focus on what happens pre farm gate. It will be a Council that will cover all aspects of South Australian agribusiness and fisheries activities.

This will allow Government to capture advice from people within the industry who have something of value to contribute, using their expertise to determine opportunities for agribusiness and fisheries/aquaculture and economic development opportunities for South Australia.

The Advisory Board of Agriculture, as the governing body for the Agricultural Bureau movement may continue to exist, if its members see that it has a future, but it will not be funded by the South Australian government.

The Bureau movement is a very effective and extensive network through the rural community, which PIRSA and other government agencies will continue to collaborate and use to deliver information and to seek advice.

NEWTON ROAD AND ST BERNARD'S ROAD

The Hon. J.J. SNELLING (Playford—Minister for Employment, Training and Further Education, Minister for Science and Information Economy, Minister for Road Safety, Minister for Veterans' Affairs): I am advised that the Minister for Transport forwarded a copy of the Road Management Plan for Newton Road and St Bernards Road to the Member for Morialta on 16 November, 2010.

AGRICULTURAL SPRAYING PRACTICES

In reply to Mr PEDERICK (Hammond) (28 October 2010).

The Hon. M.F. O'BRIEN (Napier—Minister for Agriculture, Food and Fisheries, Minister for Forests, Minister for Regional Development, Minister for the Northern Suburbs): The Australian Pesticides and Veterinary Medicines Authority is responsible for setting the conditions of use for agricultural sprays. In 2008 it finalised Operating Principles in Relation to Spray Drift Risk in order to improve the advice provided on product labels to farmers on how to minimise spray drift beyond the land to be sprayed. The application of these principles is to be science based and recognise new improved chemical application technologies. I am advised that research and discussions are ongoing in this complex area. Having said that, the government support the provision of better advice on product labels to farmers that reduces the risks of spray drift to protect human health, the environment and trade.

ANIMAL HEALTH BIOSECURITY FEE AND PROPERTY IDENTIFICATION CODE

In reply to Mr PEDERICK (Hammond) (28 October 2010).

The Hon. M.F. O'BRIEN (Napier—Minister for Agriculture, Food and Fisheries, Minister for Forests, Minister for Regional Development, Minister for the Northern Suburbs): Biosecurity SA commenced discussion about mandating Property Identification Codes (PICs) with an associated fee with the chairs of my Ministerial livestock advisory groups covering sheep, cattle, horses, goats, pigs, deer and alpacas and a representative from the South Australian Farmers Federation at a meeting on 20 August 2010, before the 2010-11 budget was presented.

Following the presentation of the budget in September 2010, which included revenue and savings targets for the Biosecurity SA Animal Health program and the PIC registration system, a second meeting was held on 24 September 2010. At this meeting Biosecurity SA informed the livestock industry and horse community representatives about the government's decision and Biosecurity SA proposals for achieving the budget targets, which included specifying the proposed PIC fee to recover costs of the PIC system and implementing a Biosecurity SA sought feedback on how the proposed Biosecurity and PIC fees could be best implemented.

Delays in the process to draft a Bill to amend the Livestock Act 1997 to enable application of the Biosecurity fee provided an opportunity for further discussion with representatives and a third meeting was held on 25 October 2010 about implementing the mandatory PIC system, the PIC fee and the Biosecurity fee. Further discussions will be held by Biosecurity SA prior to a Bill being presented to Parliament.

LOXTON LAND SALE

In reply to Mr PEDERICK (Hammond) (10 November 2010).

The Hon. M.F. O'BRIEN (Napier—Minister for Agriculture, Food and Fisheries, Minister for Forests, Minister for Regional Development, Minister for the Northern Suburbs): I am advised that the proceeds received for the sale of the two lots and associated buildings at Bookpurnong Road, Loxton was \$315,000 in 2009-10.

As per Department of the Premier and Cabinet Circular PC114—Government Real Property Management, after adjusting for minor costs associated with the sale, and retention of part proceeds by DTF, PIRSA has been provided with \$198,000 of investing expenditure authority in 2010-11. The funding is being utilised to upgrade fire safety systems at Struan Offices and Research Centre and to upgrade the Ceduna Fruit Fly Quarantine Station.

The sale of the third lot at Loxton in December 2010 is expected to generate sale proceeds of approximately \$70,000. The recently revised DPC Circular 114 provides for PIRSA to receive investing expenditure authority of 50 per cent of the proceeds (approximately \$35,000) for a Cabinet approved project or program. 'PIRSA intends to utilise these relatively minor proceeds for further regional works, subject to DTF confirmation that a 50 per cent portion of sale proceeds can be retained by the agency.

LANGHORNE CREEK PIPELINE

In reply to Mr PEDERICK (Hammond) (10 November 2010).

The Hon. M.F. O'BRIEN (Napier—Minister for Agriculture, Food and Fisheries, Minister for Forests, Minister for Regional Development, Minister for the Northern Suburbs): The full costs of the pipeline are currently being finalised. They are expected to come in at between \$91 million and \$92 million. This includes the construction and development costs of \$90.281 million paid to 30 June 2010.

The defects liability period ran for a 12 month period, from commissioning and handover to the company on 30 October 2009 to 29 October 2010. No project funds were used for any defect rectification. Defect rectification costs were born by the lead contractor. Lead Engineering and Construction.

All payments due to the SA Government from the Commonwealth and The Creeks Pipeline Company Ltd for this project have been received in full.
